**Terms:** I assume full responsibility for any loss or damage, excepting loss or damage covered by insurance, that may come to any person (including any guests or family members with whom I choose to accompany me), boat, equipment, pier, float, boatyard or other property used in conjunction with my enjoyment of any equipment associated with sailing on vessels owned by the Club as a result of improper use, negligence, violation of any terms. I accept that the sport of sailing and the conduct of sailing are subject to certain inherent risks (drowning, concussion or other serious injuries brought about by sailboat hardware and rigging, namely the vessel's boom, sheets, rope, line, wires). I accept the responsibility of installing a kill-switch between myself and an outboard engine when operating a vessel belonging to the club that is equipped with an outboard engine. I assume all risks on land and on the water in participation of Conditional Access to Club assets. I further agree to hold the Club's Board members, Fleet Captains, and managers of the host location, harmless for personal injuries, death and/or property damage.
